**ROLLING HILLS CONDOMINIUM ASSOCIATION, INC.
RESOLUTION RELATING TO THE IMPOSITION OF
SPECIAL SNOW ASSESSMENT FOR 2015**

WHEREAS, this Resolution is made this 13th day of July, 2015, by **ROLLING HILLS CONDOMINIUM ASSOCIATION, INC.**, a New Jersey non-profit corporation, located in the Township of Andover, County of Sussex, and State of New Jersey.

WHEREAS, by the Master Deed dated December 15, 1982 and recorded May 31, 1983, in the Office of Sussex County Clerk in Deed Book 1114, Page 109, et seq.; said Master Deed was re-recorded on December 20, 1983, in Deed Book 1155, Page 201, and as amended, the condominium has been established upon certain lands in the Township of Andover, County of Sussex and State of New Jersey, all pursuant to N.J.S.A. 46:8B-1, et seq.; and

WHEREAS, Section 46:8B-13d of the Condominium Act of New Jersey provides that the By-Laws of an Association may provide a method for the "enforcement of reasonable administrative rules and regulations relating to the operation, use, maintenance and enjoyment of the Units and of the common elements including limited common elements"; and

WHEREAS, the Governing Documents empower the Board with all duties necessary for the proper conduct and administration of the affairs of the Association and the operation and maintenance of the Development and to do or cause to be done all such lawful acts and things as are not by law, or by the Governing Documents, directed or required to be done or exercised by members of the Association or Unit Owners, or by others; and

WHEREAS, Article V, Section 10(c) of the By-Laws provides that the Board has the power to "adjust or increase the amount of any annual assessment. . . and to levy and collect in addition thereto, special assessments in such amounts as the Board may deem proper. . .;" and

WHEREAS, the beginning of 2015 saw an extraordinary amount of snow fall causing the budget for snow removal costs to be in excess of the budgeted amount through the end of April, 2015 and which will require a special assessment in the amount of \$54,180.00; and

WHEREAS, the Board of Directors recognizes the need to charge a special assessment to cover the costs associated with the increased snow expenses through April, 2015.

NOW, THEREFORE BE IT RESOLVED THAT, the Board of Directors hereby resolves that the budgetary shortfall caused by the excessive snow removal costs shall be collected from the Members as follows:

1. Each unit shall be assessed \$210.00 to fund a portion of the budget shortfall due to increased snow removal costs through April, 2015. The Unit Owners of record as of July 12, 2015, shall be responsible for this payment.

2. The above Special Assessment shall be due on or before August 1, 2015. However, each Unit Owner may pay the Special Assessment in six (6) equal monthly installments of \$35.00, due on August 1, 2015, September 1, 2015, October 1, 2015, November 1, 2015, December 1, 2015 and January 1, 2015. The Special Assessment is in addition to the regular monthly assessment.


